## JOB DESCRIPTION <sup>1</sup>

The tasks a Bridal Fashion and Photographic Make-Up Artist is expected to perform include:

- Delivering high quality professional bridal make-up services
- Consulting, advising, marketing and selling a range of beauty treatments
- Performing various duties such as providing skin care, applying make-up, etc.
- Applying face and body treatments
- Providing advice about skincare and cosmetics
- Applying air-brush make-up

- Knowledge of anatomy, physiology and pathology for skin treatments
- Skilled in principles and practice of skin therapies
- Knowledge of basic ailments, contraindications, contra-actions, treatment plans, etc.
- Knowledge of range and use of product available for facial treatment suitable for different skin types
- Familiar with the kinds of foundation to be used
- Proficient in corrective make-up techniques to suit the face shape
- Knowledge of hi-definition make-up
- Knowledge of colour theory, warming and cooling colours
- Proficient in designing make-up with mood board
- Proficient in period make-up, bridal make-up variation for different types and occasions
- Skilled in airbrush make-up design
- Knowledge of chemical compounds found in hair and beauty products
